- Parsonage: flooring replaced, painting completed, hot water heater repaired, new washer/dryer, old air conditioner removed from master bedroom, hole repaired, working on getting matching siding,
- Upcoming: parsonage door needs to be either repaired or replaced. Will work on when weather warms up again
- Church had a lot of water coming in this spring, had major repair of roof including repaired ridge caps, will have to do a couple more in the spring. Insulation was damaged in mechanical room, removed and replaced.
- Drains cleaned in women's bathroom, kitchen and mechanical room
