- Parsonage updates have been completed; bill from Dave Gar given to Joslyn. Carpet billed separately.
- Hot water heater bottom element burned out in parsonage. Able to fix.
- Dishwasher in parsonage checked due to recent leak. Seal okay, no observed issues or leaking when checked.
- Parsonage floor drain draining really slow. May have to be worked on.
- 5 Star Roofing sent bill for Church repair for \$4,800. Removed shingles, checked flashing, leak fixed and shingles filled back in. Only one side repaired, still need to complete fix on East side. Company in agreement to accept payment for half of repair (\$2,400) and the rest of the payment to be received when the repair fully completed. Also provided guarantee that leaking spot will not leak for one year from repair completion. Bill given to Pastor Heller to give to Joslyn.
- No repair to parking lot completed in 2024, because no one available to complete. Looking to purchase tarring machine. Options discussed: tarring machine with torch and pallet of tar-\$3,497, tarring machine with torch and pallet of tar \$2,787. Previous years cost of having company come in and tar around \$6,000-\$7,000.
- Casey visited with county to see if there would be a discount, county offered to have us borrow their machine. Discussion with availability and cost of tar.
- Parking lot maintenance/repair to be discussed next meeting. Machines discussed can be viewed at pavemade.com (hot box 10)
- Parsonage front door needs to be replaced/repaired
- Adding another light fixture for the pink light used for funerals so can be switched between the white and pink light
- Lights in the women's bathroom replaced by Kevin and Ray
